1. INTRODUCTION

Environment Reporter (ER) is a utility that analyses your system build environment and creates a report for internal and external use. The ER does not transmit any information without your explicit permission and you may edit the report prior to submission to Programming Research.

2. POLICY

2.1 What Type of Information does ER collect?

Five types of information will be collected:

- A. Contact Details - general information about the company and contact person:
 - a. Company Name
 - b. Company Location
 - c. Country
 - d. Contact Name
 - e. Contact Email
 - f. Virtual Machine (Yes/No)

This information is only required if you have requested an evaluation of our software. Failure to provide such information will not prevent you from collecting the information about your system environment for internal use but will prevent an evaluation proceeding.

- B. System Information – details about your operating system architecture, type and version.
- C. Build Information - details about your build tool (e.g. name and version).
- D. Compiler Information – details about your compiler, the options used and libraries linked.
- E. Version Control System – the name and version of your version control system.

Programming Research does not use or leave any residual technologies such as cookies or web beacons to collect information from your machine.

2.2 Do I have the right to edit the Report?

Yes, you can edit the Report, but failure to provide correct and full information about your system environment will delay an evaluation proceeding.

You control the distribution process. If you agree to send it to Programming Research it will remain confidential.

2.3 How is the collected information used?

The collected information will be used

- a. To confirm that your environment is supported by our products
- b. To prepare evaluation configurations
- c. To provide the information necessary for us to support you appropriately at all stages of your evaluation and in any subsequent usage of the product should you decide to purchase it.

We also use your personal information to communicate with you. We may send certain mandatory service communications such as welcome letters, billing reminders, information on technical service issues and security announcements.

Additionally, with your permission, we may occasionally send you product surveys or promotional mailings to inform you of other products or services available from us.

2.4 Sharing your personal information

Except as described in this statement, we will NOT disclose your personal information to any third party outside of Programming Research and its controlled subsidiaries and affiliates without your explicit consent.

2.5 Security of Your Personal Information

Programming Research is committed to protecting the security of your personal information. We use a variety of security technologies and procedures to help protect your personal information from unauthorized access, use, or disclosure. For example, we store the personal information we collect on computer systems with limited access, which are located in controlled facilities. When we transmit highly confidential information (such as a credit card number or password) over the Internet, we protect it through the use of encryption, such as the Secure Socket Layer (SSL) protocol. If a password is used to help protect your accounts and personal information, it is your responsibility to keep your password confidential. Do not share this information with anyone. If you are sharing a computer with anyone you should always log out before leaving a site or service to protect access to your information from subsequent users.
